

CHAPTER VII

The particulars of any Arrangement that exists for consultation with or representation by the member of the Public in Relation to the formulation or its policy for implementation thereof

DISTRICT PUBLIC GRIEVANCES REDRESSAL COMMITTEE

This committee meets periodically under the Chairmanship of a Minister designated by the Government for the district. The public is free to air its grievances regarding development works, unauthorized occupation of Panchayat Samiti and Zila Parishad property, misappropriation of Panchayat Samiti & Zila Parishad funds and negligence on the part of the Government and employees of Panchayati Raj Bodies. The District Development & Panchayat Officer, XEN (PR), Deputy Chief Executive Officer, Zila Parishad, Additional Deputy Commissioner (D) and Development Officer (Woman Programme) have to reply to the questions raised, by the public to the satisfaction of the chair. It automatically provides a platform to the public for consultations in relation to the formulation of development Schemes and their implementation.

SUB DIVISIONAL GRIEVANCES REDRESSAL COMMITTEE

This committee meets periodically under the Chairmanship of a Sub Divisional Magistrate with the concerned Block Development & Panchayat Officer and numbers has to reply the questions raised by the public to the satisfaction of the chair regarding development issues of the block.

QUARTERLY MEETING OF SARPANCHES AND PANCHES OF THE BLOCK

This committee meets quarterly. The panch and sarpanches are free to air their grievances regarding execution of development works and also the administrative difficulties faced by them. The departmental officer have to reply their quarries and satisfy them.

VILLAGE TOURING

All officers of department from B.D.P.O. onward upto the level of D.R.D.P. conduct village touring for checking of development works and guide the gram panchayat regarding execution of works by the panchayat. It provides a platform for interaction with the public whereby grievances of the rural populat are addressed and remedical action initiated. XEN/S.D.O. (PR) also conduct tours in the villages and inspect the work executed by the panchayats and also guide them regarding the technical aspects of the works.

PUBLIC MEETING & AT BLOCK LEVEL

These meetings are attended by the Departmental Officers and officials, both of administrative and technical side. Arrangements for proper training to the representatives of the Panchayati Raj Institutions regarding execution of development Works and maintenance of Panchayat record have already been made. The departmental officer provides mechanisms taking into account the public concern about its suggestion/observation/feedback. Information received from the public is properly in taken into accounts preparing district plans.

State Level vigilance & Monitoring Committee has been constituted at the State Level for the monitoring, reviewing & guiding the implementation of Centrally Sponsored Schemes. The MLAs who are elected representatives are also members of this committee.

All the State/District Level Vigilance & Monitoring Committees have also been established for reviewing monitoring various Centrally/Sponsored Schemes. These committee are headed

by the M.P. of the district and MLAs, Chairman of Zila Parishad & Panchayat Samiti & Other prominent persons of Public are also members of the committee.
